Raising a Concern/Complaint

Should you feel the need to raise a concern or make a formal complaint, please inform the Manager who will endeavour to provide a full response to you within twenty working days.

You may raise your concern or complaint in a variety of ways (text, online, letter or residents' meetings). Putting your concerns in writing will best ensure we understand them fully.

Please let the Manager know if you would like information regarding independent advocacy services that can support

you to raise a concern or complaint. If you prefer to report something anonymously, you may do so by using the 'suggestion box' located in the kitchen of the branch.

If the Manager is unable to satisfactorily resolve the concern or complaint, or if you or your family are not satisfied with the outcome, please put your complaint in writing to the Regional Manager/Director who will endeavour to resolve your complaint within 20 working days of the escalation.
